Product description: Complete dietetic pet food for dogs suitable for the dissolution and reduction of struvite-based stones.

Composition:

CHICKEN: chicken (meat) 40%, pork (liver) 5%, rice 5%, salmon oil 4%, XOS, mineral substances, MOS, grape polyphenols, xylose.

Urine acidifying additive: DL-methionine.

TURKEY: turkey (meat) 40%, pork (liver) 5%, rice 5%, salmon oil 4%, XOS, mineral substances, MOS, grape polyphenols, xylose.

Urine acidifying additive: DL-methionine.

STRUVITE is a complete pet food for dogs with urine acidification properties, integrated with prebiotics (XOS and MOS) and antioxidant polyphenols extracted from *Vitis vinifera*.

The diet has a reduced magnesium and potassium content to avoid the formation of struvite crystals. It is formulated with a reduced content of high-quality crude protein, in order to reduce the incidence of bacterial infections in the urinary tract. Finally, the inclusion of salmon oil completes the recipe, ensuring the intake of omega-3 fatty acids.

The production process is carried out according to the procedures of the Quality Management System, controlled by applying the HACCP method. It involves the use of category 3 by-products, ground, mixed with thickeners, vegetable gelling agents and supplements. The product is then canned. Cans are hermetically sealed, labeled, packed, and stocked in our warehouse.

Additives: Nutritional additives/kg: Vitamin A 7000 IU, Vitamin D3 500 IU, Vitamin E 60 mg, Vitamin B1 1 mg, Vitamin B2 2.4 mg, Vitamin B5 2 mg, Vitamin B12 0.004 mg, Vitamin PP 4 mg, DL-methionine 1440 mg, Choline 270 mg (choline chloride), iron 1.6 mg (iron [II] chelate of glycine hydrate), copper 1.15 mg (cupric chelate of glycine hydrate), manganese 1.2 mg (manganese chelate of glycine hydrate), zinc 10 mg (zinc chelate of glycine hydrate), selenium 0,08 mg (sodium selenite).
