**INTESTINAL** is a balanced pet food for the supply of vitamins and minerals, integrated with prebiotics (XOS and MOS) and polyphenols extracted from *Vitis vinifera*. The diet was formulated with highly digestible proteins, as they are subjected to the process of hydrolysis and prebiotic fiber.

The production process is carried out according to the procedures of the Quality Management System, controlled by applying the HACCP method. It involves the use of category 3 by-products, ground, mixed with thickeners, vegetable gelling agents and supplements. The product is then canned. Cans are hermetically sealed, labeled, packed, and stocked in our warehouse.

Additives: Nutritional additives/kg: Vitamin A 7000 IU, Vitamin D3 500 IU, Taurine 1000 mg, Vitamin E 60 mg, Vitamin B1 1 mg, Vitamin B2 2.4 mg, Vitamin B5 2 mg, Vitamin B12 0.004 mg, Vitamin PP 4 mg, L-carnitine 180mg, Choline 270 mg (choline chloride), iron 3 mg (iron [II] chelate of glycine hydrate), manganese 1.2 mg (manganese chelate of glycine hydrate), zinc 10 mg (zinc chelate of glycine hydrate), selenium 0,08 mg (sodium selenite).
