Product description: Complete food for adult dogs

Composition:

CHICKEN with PINEAPPLE: meat and animal derivatives (chicken 92%), fruit (pineapple 4%), minerals, sugars.

DUCK with KIWI: meat and animal derivatives (92% duck), fruit (4% kiwi), minerals, sugars.

QUAIL with PEAR: meat and animal derivatives (quail 92%), fruit (pear 4%), minerals, sugars.

TURKEY with RASPBERRY: meat and animal derivatives (turkey 92%), fruit (raspberry 4%), minerals, sugars.

RABBIT with BANANA: meat and animal derivatives (rabbit 92%), fruit (banana 4%), minerals, sugars.

BEEF with MELON: meat and animal derivatives (beef 92%), fruit (melon 4%), minerals, sugars.

WHITE FISH with APPLE: fish and fish by-products (white fish 92%), fruit (apple 4%), minerals, sugars.

SALMON with BLUEBERRY: fish and fish by-products (salmon 92%), fruit (blueberry 4%), minerals, sugars.

STURGEON with STRAWBERRY: fish and fish by-products (92% sturgeon), fruit (4% strawberry), minerals, sugars.

The production process is carried out according to the procedures of the Quality Management System, controlled by applying the HACCP method. It involves the use of category 3 by-products, ground, mixed with thickeners, vegetable gelling agents and supplements. The product is then canned. Cans are hermetically sealed, labeled, packed, and stocked in our warehouse.

Additives: Nutritional additives / kg: Vitamin A 5,000 IU, Vitamin D₃ 335 IU, Vitamin E 41 mg, Iron 1.58 mg (iron carbonate [II] 3.29 mg), Copper 0.63 mg (cupric sulphate, pentahydrate 2.5 mg), Manganese 7.97 mg (Manganese oxide [II] 10.3 mg), Iodine 10 mg (Potassium iodide 131 mg), Zinc 6.42 mg (Zinc oxide 8 mg), Selenium 0.0064 mg (sodium selenite 0.014 mg).

Product requirements: the finished product must have a characteristic aroma of cooked meat, compatible with the raw materials used in the formula. The product must not show anomalous and / or artificial colours. The product must be in line with the requirements foreseen by the EC Reg. 1069/2009 for the presence/absence of Salmonella (absent in 25 g, n=5, c=0, M=0) and Enterobacteriaceae (n=5, c=2, m=10, M=300 in 1 g).
