The production process is carried out according to the procedures of the Quality Management System, controlled by applying the HACCP method. It involves the use of category 3 by-products, ground, mixed with thickeners, vegetable gelling agents and supplements. The product is then canned. Cans are hermetically sealed, labeled, packed, and stocked in our warehouse.
